1. Dennis A. Contri, age 50, of 764 Owego Road, Candor

Arrested on 9/12/2017, 11:00 PM for criminal trespass 2nd.

This resulted from the subject entering a residence without permission. The defendant was arraigned before Justice Pat Hogan of the Town of Owego Court and was ROR'd. He is scheduled to appear in the Town of Candor in front of Justice Gary Dence 9/25/2017 at 3:00 PM.

2. Duke W. Williams, age 40, homeless.

Arrested on 9/13/2017, 4:47 AM for two counts of endangering the welfare of a child and trespassing.

This resulted from a disturbance that occurred at 333 Tyler Hollow Rd. in Spencer. The defendant was arraigned before Justice Joseph Fravel and remanded to Tioga County Jail on \$1500 bail - \$3000 bond. He is scheduled to appear in the Town of Spencer Court in front of Justice Lawrence Bleck on 9/20/2017 at 3:30 PM.
