1. On the morning of 9/8/25, the Tioga County Sheriff's Office arrested 24-year-old Noel C. Guadalupe of Bronx, NY, 30-year-old Nikoly D. Da Silva of Stroudsburg, PA, and Tyquan S. Jacobs of Mount Vernon, NY following the report of a larceny in progress at the Best Buy Distribution Center in the Town of Nichols. All three subjects are accused of entering the perimeter fence, forcibly gaining access to a storage trailer and stealing property. The subjects also allegedly removed and staged additional property from the trailer with the intent of stealing it. The Criminal Investigation Division charged all three subjects with Attempted Grand Larceny 3rd degree (E felony), Grand Larceny 4th (E felony) and Criminal Mischief 3rd (E felony). Guadalupe was also arrested as a Fugitive from Justice from the Commonwealth of Pennsylvania for previously violating conditions of parole. Jacobs and Da Silva were arraigned and released at CAP Court pending future proceedings in Nichols Town Court. Guadalupe was remanded to the Tioga County Jail pending future proceedings in Tioga County Court and extradition to Pennsylvania.
2. On 8/22/25, the Tioga County Sheriff's Office arrested Daniel R. Myers, age 22, of Newfield, NY, following a traffic stop in the Village of Spencer. After further investigation, Myers was determined to be operating a motor vehicle while under the influence of an alcoholic beverage and subsequently charged with Driving While Intoxicated and Driving with BAC > .08, both Unclassified Misdemeanors. Myers was issued appearance tickets to appear in Town of Spencer Court at a later date.
3. On 09/01/2025, the Tioga County Sheriff's Office arrested Kimberley Wolf, age 58, of Yuma Arizona, for a Bench Warrant issued by the Town of Newark Valley. The warrant was issued as a result of Wolf's failure to appear in connection with a case for the charges of Menacing 2nd, an A Misdemeanor, and Reckless Endangerment 2nd, an A Misdemeanor. Wolf was arraigned at CAP, with Justice Hogan, and was released on his own recognizance and is to appear in the Town of Newark Valley Court at a later date.
4. On 09/09/2025 the Tioga County Sheriff's Office arrested Miles A. Floyd, age 28, of the Town of Nichols for Making Terroristic Threats. The arrest resulted from an investigation into a subject making terroristic threats to several people at an address in the Town of Owego. Floyd was arraigned at CAP by Justice Grinage and was held on said charges at the Tioga County Jail with a bail amount of \$20,000, \$50,000 bond, and \$100,000 partially surety bond. Floyd is to appear in the Town of Owego Court at a later date.

5. On 9/2/25, the Tioga County Sheriff's Office arrested Vikki L. Frisbie, age 30, of Waverly, NY, following a traffic stop on Chemung Street in the Village of Waverly. Following an investigation, Frisbie claimed to be another individual, was found to be in possession of a quantity of methamphetamine and had active warrants out of the Waverly Police Department and Bradford County, Pennsylvania. Frisbie was charged with Criminal Possession of a Controlled Substance Seventh degree, and Criminal Impersonation in the Second degree, both Class A Misdemeanors, and as a Fugitive From Justice. Frisbie was arraigned in Tioga County CAP Court and remanded to the custody of the Jail Division pending extradition to Pennsylvania. The Tioga County Sheriff's Office was assisted on the scene by the New York State Police and Waverly Police Department.
