1. **Joshua Raymond Cron, age 37, of 6 Mason Ave., Binghamton, NY**

Arrested on 11/23/10 at 3:50 PM for Aggravated Unlicensed Operation 3rd.

This charge resulted from an investigation of a complaint at the Owego Heights Trailer Park in the town of Tioga. Cron admitted to operating a vehicle on Route 96 while allegedly holding a suspended New York State license. Cron was issued an appearance ticket to appear before Justice Paul Martin, Town of Tioga Court, on 12/1/10.

2. **Lukas D. Monell, age 21, of 52 Dubois Rd., Barton, NY**
