**1. Jason M. Speer, age 36, of 46 Guiles Rd., Barton, NY**

Arrested on 10/7/11 at 1:10 AM for Driving While Intoxicated (misdemeanor), Driving with .08% or More Blood Alcohol Content, Unlawfully Fleeing a Police Officer, Inadequate Tail Lamps, Failed to Yield to an Emergency Vehicle, 2 counts of Failed to Stop at a Stop Sign, and Moved from Lane Unsafely.

Speer was arraigned before Justice David Boland, Village of Owego Court, and was remanded to the Tioga County Jail on \$500 cash or \$2,000 bond.

2. The Tioga County Sheriff's Office investigated a one-car motor vehicle accident on 10/7/11 at 1:15 PM in the town of Barton. A vehicle operated by Christopher Tackett, age 28, of 240 ½ Lincoln Ave., Lavena, OH, was traveling in a southerly direction on Rt. 34. Tackett looked away from the road and was adjusting an electronic device when the vehicle exited the lane and struck a guardrail. Tackett reacted and turned the vehicle back across the road, struck another guardrail, and went over the embankment at 592 Rt. 34. Tackett was charged with moved from lane unsafely.

The Lockwood Fire Department and Greater Valley Ambulance assisted at the scene.

**3. Elijah E. Williams, age 26, of 896 Midline Rd., Freeville, NY**

Arrested on 10/9/11 at 1:18 AM for Aggravated Unlicensed Operation 2<sup>nd</sup>, Headlight Violation, Muffler Violation, and Unlicensed Operator.

This charge resulted from a vehicle stop on E. Tioga St., in the Village of Spencer, for the above equipment violations. Williams was issued appearance tickets to appear before Justice Barb Lester, Village of Spencer Court, on 10/12/11.

Arrested on 10/10/11 at 8:19 PM for Criminal Contempt of Court Order, and Endangering the Welfare of a Child.

These charges resulted from an investigation of a runaway complaint. Stoughton and the female juvenile runaway were located in a shed on Stoughton's property. The female juvenile also had an order of protection against Stoughton. Stoughton was arraigned before Justice John Schaffer, Town of Newark Valley Court, and was remanded to the Tioga county Jail on \$4,000 bail/\$8,000 bond. Stoughton is to reappear before Justice John Schaffer, Town of Newark Valley Court, on 10/11/11.

**6. Amy V. Germaine, age 32, of 9 Creek Dr., Dryden, NY**

Arrested on 10/10/11 at 11:40 PM for Aggravated Unlicensed Operation 3<sup>rd</sup>.

This charge resulted from a vehicle stop on Wilson Creek Rd. in the town of Newark Valley. The vehicle Germaine was driving matched the description of a vehicle that was involved in a disturbance. Germaine was issued an appearance ticket to appear before Justice Todd Smith, Town of Newark Valley Court, on 11/10/11.

**7. Vinnakone Vongkhamchaun, age 35, of 1024 Beechwood Ln, Vestal, NY**

Arrested on 10/7/11 at 8:29 AM for Aggravated Unlicensed Operation 2<sup>nd</sup>, and Uninspected Motor Vehicle.

These charges resulted from a vehicle stop on Fifth Ave. in the town of Owego. Vongkhamchaun was arraigned before Justice John Schumacher, Town of Owego Court, and was released on his own recognizance.
