1. **Jessica M. Shirley, age 18, of 498-A Glenmary Drive, Owego, NY**  
Arrested on 6/2/13 at 1:40 PM for Criminal Contempt 2<sup>nd</sup>.

This charge resulted from a complaint in which Shirley violated specific orders on an order of protection. Shirley was issued an appearance ticket to appear before Justice Gary Dence, Town of Candor Court, on 6/17/13.

2. **Christopher Hartman, age 36, of 3010 State Route 17C, Tioga Center, NY**  
Arrested on 6/2/13 at 4:21 PM for Disorderly Conduct.

These charges resulted from a disturbance at Cole Auction in Tioga Center. Hartman was issued an appearance ticket to appear before Justice Paul Martin, Town of Tioga Court, on 6/5/13.
