On 05/30/2024 the Tioga County Sheriff's Office arrested Wayne Floyd, age 33, of the Town of Nichols, for:

- A Bench Warrant issued by County Court for one count of Possession of Stolen Property in the Fourth Degree, a Felony, which he was arraigned on before Judge Schumacher on 5/31/24 and remanded to the Tioga County Jail, without bail, pending a future court date.
- An Arrest Warrant issued by County Court for one count of Bail Jumping in the Second Degree, a Felony, which he was arraigned on in CAP before Justice Schaffer, and remanded to the Tioga County Jail on a \$30,000/\$60,000 Bail/Bond, with a return date to the Town of Nichols Court with Justice Grinage on 06/27/2024.
- A Bench Warrant issued by the Town of Nichols Court for one count of Assault in the Third Degree, a Misdemeanor, and one count of Bail Jumping in the Third Degree, a Misdemeanor, which he was arraigned on in CAP before Justice Schaffer, and released on his own recognizance with a return date to the Town of Nichols Court with Justice Lute on 06/27/2024.
- An Arrest Warrant issued by the Town of Nichols Court for one count of Aggravated Criminal Contempt, a Felony, one count of Criminal Contempt in the Second Degree, a Misdemeanor, and one count of Assault in the Third Degree, a Misdemeanor, which he was arraigned on in CAP before Justice Schaffer, and released on his own recognizance with a return date to the Town of Nichols Court with Justice Lute on 06/27/2024.
- An Arrest Warrant issued by the Town of Nichols Court for one count of Criminal Contempt in the Second Degree, a Misdemeanor, one count of Resisting Arrest, a Misdemeanor, one count of Unlawful Fleeing Police in a Motor-Vehicle in the Third Degree, a Misdemeanor, one count Aggravated Unlicensed Operation of a Motor Vehicle in the Second Degree, a Misdemeanor, one count Reckless Driving, a Misdemeanor, along with other V&T Law Violations, which he was arraigned on in CAP before Justice Schaffer, and remanded on a \$30,000/\$60,000 Bail/Bond, with a return date to the Town of Nichols Court with Justice Lute on 06/27/2024.

The service of Floyd's warrants were conducted in the Town of Nichols by members of the Tioga County Sheriff's Office and the New York State Police, with the assistance of members of the public.
